### O107'S ROCKIN' MUSKOKA GETAWAY! CONTEST RULES

THE Q107'S ROCKIN' MUSKOKA GETAWAY! CONTEST (THE "CONTEST") WILL BE CONDUCTED IN CANADA ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THEIR PROVINCE OR TERRITORY OF RESIDENCE OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "CONTEST RULES").

### 1. ELIGIBILITY.

- 1.1 To be eligible for this Contest, an individual must:
  - (a) be a legal resident of Canada;
  - (b) be of nineteen (19) years of age or older at the time of entry; and
  - (c) be able to participate in the Prize (as defined below) between June 14, 2024 and June 16, 2024.
- 1.2 The following people are not eligible to enter the Contest:
  - (a) Employees of Corus Radio Inc., operating as CILQ-FM (the "**Station**") and its parent, affiliates, subsidiaries, related companies, successors and assigns (together with the Station, "**Corus**");

  - (c) Any person who has been confirmed as a winner of two (2) Corus administered contests within six (6) months preceding the Contest start date indicated below wit; and
  - (d) The household members of any of the parties listed in Section (a) to (d) above.
- 1.3 The Sponsors shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to the Sponsors for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. The Sponsors reserve the right, in their sole discretion, to disqualify any entrant should such an entrant at any stage supply information that does not meet these requirements.
- **2. CONTEST PERIOD.** The Contest begins at 10:00 am Eastern Time ("**ET**") on April 15, 2024 and ends at 3:00 pm ET on May 23, 2024 (the "**Contest Period**") after which time the Contest will be closed and no further entries shall be accepted.

# 3. HOW TO ENTER.

- 3.1 There is no purchase necessary to enter the Contest. To enter, go online, complete and submit the entry form located at <a href="https://www.q107.com">www.q107.com</a> (the "Contest Microsite"). No entries will be accepted by any other means.
- 3.2 After entering online on the Contest Microsite, starting on Apil 22, 2024, listen to the Station Monday through Friday (excluding statutory holidays) at approximately 9:00 a.m., 1:00 p.m. and 3:00 p.m.ET, listen for the hosts to call out two (2) entrants names (the "Cue To Call"). Upon hearing the Cue To Call, entrants have seven (7) minutes to call into the Station at 416-870-7625 (the "Contest Line"). The first entrant to call into the Contest Line, will qualify for a Grand Prize (as defined below).
- 3.3 Limit of one (1) entry per household per day. In the case of multiple entries, only the first eligible entry will be considered.
- 3.4 All entries become the sole property of the Sponsors and will not be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. Unless otherwise set out herein, no communication or correspondence will be exchanged with entrants except with those selected as a potential winner.
- 3.5 Entries received online shall be deemed to be submitted by the authorized account holder of the email address associated with the entry. For the purpose of the Contest Rules, "authorized account holder" of an e-mail address is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider, or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Any entrant may be required to provide the Sponsors with proof that they are the authorized account holder of the e-mail address associated with their entry.

# 4. PRIZES.

- 4.1 There are five (5) grand prizes (collectively, the "**Grand Prizes**" each, a "**Grand Prize**") available to be won by the Grand Prize winners (each a "**Grand Prize Winner**") each consisting of: a trip for two (2) to The Muskoka BeerSpa in Trenton, Ontario (the "**Destination**") which shall include:
  - (a) Two (2) nights cabin accommodation at The Muskoka BeerSpa, or other such venue (the "Hotel") to be selected by the Parties in their sole discretion for the Grand Prize Winner and one (1) guest (the "Guest") based on double occupancy unless otherwise indicated in a BeerSpa glamping cabin;

  - (c) Two (2) breakfasts at the Muskoka BeerSpa brewery for two (2);
  - (d) One (1) taco lunch at El Gringos for two (2);

- (g) A two hundred and fifty Canadian dollar (CDN\$250) gift card to Muskoa BeerSpa;
- (h) One (1) thirty (30) minute massage for two (2) from Wink & Wave; and
- (i) One (1) "Two Beer Pedicure" for the Grand Prize Winner and Guest.
- 4.2 Each Grand Prize has an approximate value of two thousand and five hundred Canadian dollars (CDN \$2,500).
- 4.3 Grand Prizes are hereafter collectively referred to as "**Prize**" or "**Prizes**". Grand Prize Winners are hereafter collectively referred to as a "**Winner**" or "**Winners**".
- 4.4 Winners are not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.
- 4.5 The Sponsors and/or the Sponsors' representatives will contact the Winners to coordinate the provision of the Prizes within three (3) days once such Winners have been successfully contacted and notified of their Prize and fulfilled the requirements set out herein.

### 5. PRIZE CONDITIONS.

- 5.1 Winner and their Guest must be available to participate in the Prize from June 14, 2024 through June 16, 2024. Should Winner and/or Guest be unable to participate on the dates and times designated by the Sponsors, the Prize will be forfeited and awarded to an alternate winner.
- 5.2 Winners and Guests will be responsible for any other expense not explicitly included in the Prize including but not limited to: transportation to and from the Hotel, taxes, gratuities, telephone calls, and in-room charges. Winners may be required to present a valid major credit card upon check-in at the hotel to cover any expenses over and above the standard room charge.

Corus is not responsible for administering or ensuring compliance with the terms and conditions of the event tickets, gift cards or gift certificates.
- 5.4 Guest must: (i) be of the age of majority or older in their province or territory of residence; and (ii) comply with the Contest Rules and sign and return the Release (described below).
- 5.5 Prizes must be accepted as awarded and cannot be transferred, assigned, substituted or redeemed for cash, except at the sole discretion of the Sponsors. Any unused, unclaimed or declined portion of a Prize will be forfeited, have no cash value and the Sponsors shall have no obligation to provide either an alternative or value-in-kind. # 6. SELECTION.

6.1 **Qualifier Selection.** One hundred and fifty (150) Qualifiers (as defined below) shall be selected by random draw from all eligible entries received during the applicable Week as follows:

- 6.2 **Winner Selection.** Five (5) Winners shall be selected as follows:
  - (a) Starting on or about each Friday, beginning April 26, 2024 in Toronto, Ontario, a total of five (5) Qualifiers will be selected by random draw from all eligible Qualifiers confirmed during the Contest Period. Each Qualifier shall be eligible to win only one (1) Prize. The odds of being selected as a potential winner is dependent on the Week and the number remaining Qualifiers. Before being declared a Winner, each selected Qualifier shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited, mathematical skill-testing question to be administered during a pre-arranged telephone call or by e-mail to comply with the Contest Rules and to sign and return the Release (described below).

If the selected entrant does not respond accordingly, they will be disqualified and will not receive a Prize and another entrant may be selected in the Sponsors' sole discretion until such time as an entrant satisfies the terms set out herein. The Sponsors are not responsible for the failure for any reason whatsoever of a selected entrant to receive notification or for the Sponsors to receive a selected entrant's response.
  - (c) If, as a result of an error relating to the entry process, drawing or any other aspect of the Contest, there are more selected entrants than contemplated in these Contest Rules, there will be a random draw amongst all eligible Prize claimants after the Contest's closing date to award the correct number of Prizes.

The Sponsors are not responsible for any incorrect or inaccurate information, whether caused by website users or by any of the equipment or programming associated with or utilized in the Contest or by any technical or human error which may occur in the administration of the Contest. The Sponsors assume no responsibility or liability in the event that the Contest cannot be conducted as planned for any reason, including reasons beyond the control of the Sponsors, such as infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or corruption of the administration, security, fairness, integrity or proper conduct of this Contest and/or the Contest Microsite.

- 11.2 Each Winner further consents that: (a) any personal information they have provided in connection with this Contest may be shared with Muskoka BeerSpa for the purpose of facilitating the delivery or fulfillment of a Prize; and (b) Corus may broadcast, publish, disseminate and otherwise use a Winner's name, city/town/village and province/territory of residence, image and/or voice in connection with any promotion and/or publicity purposes without further compensation to Winner.
